**EXPRESSION OF INTEREST
Imphal, the 23rd January, 2008**

No. 2/8/04-SSA (SMA) Pt: Sarva Shiksha Abhiyan State Mission Authority, Manipur invites Expression of Interest (EOI) from **C&AG empanelled/ reputed Chartered Accountant firms (partnership/ sole proprietorship firms with one full time FCA)** in the prescribed format for shortlisting for audit of the accounts of Sarva Shiksha Abhiyan Programme being implemented in the State of Manipur for the year 2008-09.

1. The C.A. firm should have a minimum of five year of experience with sufficient staff to carry out the audit.
2. The term Full Time Partner/CA employees does not include those persons (partner/ sole) who are:-
 - i) Partner in other firms.
 - ii) Employed part-time/ full time elsewhere, practicing in their own name or engaged in practice otherwise or engaged in any other activity which would be deemed to be in practice under section 2(2) of the Chartered Accountants Act, 1949.
 - iii) Partners who have earned more professional income from other sources than their income from the firm.

Similarly, the Full Time Sole proprietor does not include a person who is a partner in other firms or is employed elsewhere or other wise engaged in any other business/ activity as mentioned above. Accordingly, a person who is a partner/ employee in another firm should not apply in his capacity as sole proprietor.

3. The last date of issue and receipt of EOI in the specified format is **28th February, 2009 by 3.00 p.m.** Incomplete formats/ format received after the prescribed last date will not be entertained.
4. The prescribed/ specified format of the EOI can be had by an application to the State Project Director (Sarva Shiksha Abhiyan) from this office at Babupara, Imphal on all working days from 11.00 am to 3pm or download from the website www.ssamanipur.nic.in
5. The EOI can also be obtained through speed post by enclosing a pre stamped self addressed envelope along with the application seeking the prescribed EOI.
6. The EOI submitted in the prescribed format and accompanied with all requisite documents on or before the last date during the specified hours, will only be considered.
7. The Expression of Interest must be delivered within the last date, by post (in a sealed envelope)/ or by hand in the office of the State Project Director, Sarva Shiksha Abhiyan, Babupara, Imphal-West, Manipur.
